
<u>Goals:</u> We aim to prevent unnoticed rights violations, inform public opinion through reports and events, and engage with European institutions for policy change.

2. Human Rights Challenges:







- Advocate for increased support and funding for civil society organizations working on human rights issues. These organizations play a crucial role in monitoring, reporting, and advocating for human rights, especially in regions with limited resources.
- Promote the development and implementation of comprehensive national human rights action plans. These plans can serve as roadmaps for addressing human rights issues, setting specific goals, and measuring progress over time.
- Advocate for the integration of regular human rights impact assessments in the legislative process. This systematic approach ensures that lawmakers consider the potential impact of policies on human rights before they are implemented.
- Introduce design thinking sessions for policy creation. This user-centric approach involves empathizing with those affected by policies, defining the problem, ideating solutions, prototyping, and testing. Applying this methodology to human rights legislation can lead to more effective and inclusive policies.
- Support community-led initiatives that empower marginalized groups. Provide funding and resources to grassroots organizations working on the ground to address specific human rights challenges within their communities.
- Establish Youth Advisory Councils specifically focused on human rights. Engaging young people in policymaking ensures fresh perspectives and empowers the next generation to actively contribute to shaping human rights policies.
- Organize legislative hackathons where lawmakers, technologists, and human rights advocates collaborate to devise innovative legislative solutions. This approach can harness diverse perspectives and expertise to draft effective and forward-thinking human rights
